Re: Joint Academic Senate / Administration Working Group on Outdoor Space for Instructional Activities Charge

Dear Colleagues,

We write to thank you for agreeing to serve on a *Joint Academic Senate / Administration Working Group on Outdoor Space for Instructional Activities*, which will be co-chaired by Vice Provost Lisa Alvarez-Cohen and Senate Chair Jenna Johnson-Hanks. Within this context, we ask that you develop general and adaptable guidelines and/or recommendations that address the following:

- 1. When shelter-in-place is lifted and public health guidance allows, what types of instructional activities are best suited to be held outside?
- 2. As SIP is gradually lifted, how should we think about outdoor spaces as a complement to indoor spaces for provisionally approved instructional activities?
- 3. Establish guidelines under which academic divisions could use outdoor spaces for instructional activities (with focus on access, ADA, IT for students participating remotely, additional necessary accommodations, and robustness to weather conditions) when these are allowed.

4. What kinds of infrastructure support (e.g., wifi, tent/structure, security, cleaning, bathroom facilities, etc.) are required or preferable for outdoor instructional activities to take place?

Given the rapidly evolving nature as well as the urgency of this matter, I ask that you produce a final report by October 23. The work of this committee will be supported by Rhiannon Lewis, Project Manager with meetings scheduled by Emily Strange, Executive Assistant.

We thank you again for your willingness to serve on this important effort.
