Re: Online Exam / Proctoring Working Group

Dear Colleagues,

The issues and challenges of remote instruction are particularly acute in the realm of assessment, particularly exams. To help the campus develop appropriate guidance to instructors and students, and to determine what investments we might make in proctoring services, we invite you to be part of a task force to address the following questions:

1. What strategies for remote exams will support learning and academic integrity? What would best support exams in large classes? Of these strategies, which best meet the needs of DSP students?

- 2. What are the principles that should underlie any decision to procure remote proctoring services or other digital tools to address issues of academic integrity, and accessibility?
- 3. What products or services for remote proctoring would best meet our needs, assuming they meet the criteria expressed in Item 2?

We want to address both the immediate needs of this semester and develop a longer range approach that would work for fully on-line courses as well as remote instruction.

Given the urgency for making decisions before the end of the semester, I humbly request that you submit your recommendations on the above by Monday, April 20th.
